In February 2022, Qarama renewed the agreement with the Lebanese Ministry of Justice which guarantees the continuation of social workers' and case managers' efforts to support children and youth in contact/conflict with the law throughout their judicial

'Making Child Protection a Right, Everywhere' was initiated by Qarama with the support of UNICEF and in collaboration with Himaya. The project aims to support the most vulnerable children and young people within the Mount Lebanon region, in order to ensure the upholding of their judicial rights.

On November 17th, 2020 the 8th edition of Women on the Front Lines e-conference was hosted by UN Women and the May Chidiac Foundation. Qarama's president Joe Maalouf was invited as a moderator, given his experience as a human rights advocate supporting vulnerable communities, where he emphasized that it is essential to continue to rightfully empower women and make sure children are protected.
